The candidates should possess the basic educational qualification and should also have a valid ICAR score card of ICAR-AIEEEA-UG for the relevant year of admission for considering to the Supernumerary seats allotted for each course.

The prescribed basic educational qualifications are,

1 For admission to B.Sc.(Hons.) Agriculture, B.Sc.(Hons) Forestry, B.Sc (Hons.) Co operation & Banking, B.Tech Biotechnology (under (KAU)

Candidates should have passed 10+2 Senior Secondary Examination of the Central Board of Secondary Education or any other examination within scope and standard found to be equivalent to the Senior Secondary Examination of a recognized Indian Board.

Candidates who have passed in the subjects Physics, Chemistry and Biology at the Plus Two level with 50% marks in Physics, Chemistry and Biology put together are eligible.

2 For admission to B.Sc.(Hons) Climate Change & Environmental Science:

Candidates should have passed 10+2 Senior Secondary Examination of the Central Board of Secondary Education or any other examination within scope and standard found to be equivalent to the Senior Secondary Examination of a recognized Indian Board.

Candidates who have passed in the subjects Physics, Chemistry and Biology at the Plus Two level with 50% marks in Physics, Chemistry and Biology put together are eligible. Candidates should have studied Mathematics as a subject in the Plus Two level.

3 B.Tech (Agri. Engg.) and B.Tech (Food Technology) courses

Candidates should have passed 10+2 Senior Secondary Examination of the Central Board of Secondary Education or any other examination within scope and standard found to be

equivalent to the Senior Secondary Examination of a recognized Indian Board.

Candidates who have passed Plus Two level examination with Physics and Mathematics as compulsory subjects and Chemistry as one of the optional subjects with atleast 45% marks put together are eligible.

GENERAL ADMISSION PROCEDURES

Candidates can submit applications through www.admissions.kau.in from 05.10.2024 onwards. All certificates/documents for proving the eligibility criteria for the course applied, proof of Date of Birth, valid ICAR score card for the relevant year of admission and other certificates as specified by the University in the application portal should be uploaded in the portal.

The collected applications/certificates/documents will be initially screened by the University to check if applications meet minimum basic academic requirements prescribed for each course, as stated above.

KAU will review the applications and rank applicants. The scoring will be based on marks in the qualifying examination (Plus Two) as stated above. The index marks for courses listed against (1) & (2) above will be calculated as the sum of marks obtained in Physics, Chemistry and Biology and that for the courses noted against Sl.No.(3) will be the sum of Physics, Chemistry and Mathematics in the qualifying ie, Plus Two examination. If there is tie in Science/Mathematics marks, then the marks of English and then the marks of Additional language/second language will be considered.

KAU will send notification to the Union Territory concerned for furnishing the selected candidates with the nomination letter from the authorities. The selected applicants will also be notified of their acceptance through e mail.

The candidates will confirm their acceptance of allotted seat by the specific deadline fixed by the University and also physically report for submission of original certificates, payment of fee and enrollment in the University.

The candidates shall submit their online application on or before the last date prescribed.

Mode of Payment

The application fee can be paid online by using the internet facility "SB COLLECT" of State Bank of India for which a link will be provided in the application portal. Also the applicant can directly remit the application fee at any of the SBI branches by using the online chalan generated through "SB COLLECT" and the bank will issue an Online Receipt on payment of the same. Any other mode of payment will not be accepted. The Application fee/additional fee once remitted will

not be refunded under any circumstances.

The application submitted after the closure date will not be considered.
