The nomination shall be accompanied by the consent in writing of the nominee agreeing to serve on the University Authority or Body, as the case may be, if elected, and declaring that he is not already a member of the authority or body, or if he is already a member, his term of office as such, would expire before the membership for which he is seeking election takes effect.

The nomination paper shall be forwarded to the Registrar and Returning Officer through Registered post or deposited in the box provided for the purpose in the office of the Registrar and Returning Officer **before 5.00 PM on 10.11.2023.**

Name and Electoral roll number should be written as shown in the Electoral Roll.

All nomination papers will be scrutinized by the Returning Officer or other Officer authorized by him on his behalf at **11.30 A.M. on 13.11.2023**.
