Details of Polling Stations, Polling areas, Electoral Roll Numbers of voters to vote at the station etc. will be published separately in all the offices of the University.

Only those whose names have been included in the electoral roll as published by the University on 27.09.2017 and corrected notification of electoral roll issued on 30.10.2017 are eligible to take part in the election and vote thereof, provided that any person who ceases to be a member of the electoral body before the date of poll shall not be entitled to participate in the election.


Copies of the electoral rolls can be had from the University office on payment of Rs.10/- per copy.

Every elector is at liberty to nominate a duly qualified person who is a member of the constituency concerned. Every nomination shall be in writing and shall be seconded in writing by another elector. Nomination should be made in prescribed form, copies of which will be supplied on request from the office of the Registrar & Returning Officer.

Last date and time for receipt of nominations is at 5.00 PM on 13.11.2017. Time and date of scrutiny of nomination is at 11.30 AM on 15.11.2017. Date of publication of the list of the candidates validly nominated is at 5.00 PM on 15.11.2017. Last date and hour for the withdrawal of Candidature is at 4.00. PM on 21. 11. 2017. Date of publication of the final list of contesting candidates is at 5.00 PM on 21.11.2017. Date and hour for poll is from 9.00 AM to 1 PM on 19.12.2017. Date and hour for scrutiny and counting of votes is at 10.00 AM on 21.12.2017. Declaration of results is on 21.12.2017. Date of publication of the results in the University office and date of effect is 29.12.2017.
