- d) Secretary – 1


Conditions:

2. The certificates to prove age and “No Academic Arrear” issued by the Head of the Institution should be furnished along with the nomination paper. Photocopies of SSLC Book etc will not be accepted as proof of age.
3. The request for withdrawal of nominations in the prescribed form should be countersigned by the Head of the College.
4. The Councilors of the Students’ Union 2024-25 of all constituent Colleges/Institution shall produce a letter of eligibility and identity proof/card issued by the Head of College/Institution before the Returning Officer at the time of voting.
