Election will be held for the following offices of the Kerala Agricultural University Union.


- President -1

Conditions:

- The contesting candidate must have course duration for at least one more year (Article XIV 6,5,8)
- Nomination forms should be submitted in person by the candidate to the Returning Officer.

3. The certificates to prove age and "No Academic Arrear" issued by the Head of the College are to be furnished along with the nomination paper. Photocopies of SSLC Book etc will not be accepted as proof of age.
4. The request for withdrawal of nominations in the prescribed form should be countersigned by the Head of the College.
5. The Councillors of the Students' Union 2021-22 of all constituent Colleges/Institute shall produce a letter of eligibility and identity proof/card issued by the Head of College/Institution before the Returning Officer at the time of voting.
