KAU-Reconstitution of the General Council-Election under Section- 10 Elected members sub-clauses (3) (4) (5) & (6) of KAU Act (Act No. 33 of 1971 as amended vide Act No. 16 of 2001) –Election Notification published.

Whereas it has become expedient to reconstitute the General Council of Kerala Agricultural University, it is hereby notified that an Election will be held to the General Council according to the principles of proportional representation by means of single transferable vote and as per provisions contained in Statute SRO No. 678/74 in the following constituencies

1	Teachers of the University	4 (Four)
2	Students of the University	2 (Two)
3	Non Teaching Staff of the University	2 (Two)
4	Permanent Labourers of the University	2 (Two)

Details of Polling Stations, Polling areas, Electoral Roll Numbers of electors to vote at the station etc. will be published.

Only those whose names have been included in the electoral roll as published by the University on 27.03.2017 and corrections issued up to 11.04.2017 are eligible to take part in the Bye election and vote thereof, provided that any person who ceases to be a member of the electoral body before the date of poll shall not be entitled to participate in the Election.

Copies of the electoral rolls can be had from the University office on payment of Rs.10/- per copy. Every elector is at liberty to nominate a duly qualified person who is a member of the constituency concerned. Every nomination shall be in writing and shall be seconded in writing by another elector Nomination should be made in prescribed form, copies of which will be supplied on request from the office of the Registrar & Returning Officer.

The envelope containing nomination paper shall be super scribed “Nomination for Election to the General Council from the Constituency of”.

The Candidate and one nominee authorized by the candidate in writing with the approval of the Returning Officer can be present at the venue of scrutiny of nomination.

Programme for the conduct of Election

Last date and time for receipt of nominations is on 12.05.2017 (Friday) at 05.00 PM Time and date of scrutiny of nomination is at 11.00 AM on 15.05.2017 (Monday). Date of publication of the list of the candidates validly nominated is on 15.05.2017 (Monday). Last date and hour for the withdrawal of Candidature is on 20.05.2017 (Saturday) at 4.00.PM. Date of publication of the final list of contesting candidates is on 20.05.2017 (Saturday). Date and hour of poll is on 13.06.2017 (Tuesday) from 9.AM to 1 PM. Date and hour for scrutiny and counting of votes is on 15.06.2017 (Thursday) at 10.AM. Declaration of results is on 15.06.2017 (Thursday). Date of publication of the results in the University office and date of effect is on 18.06.2017 (Sunday).
