Every elector shall be at liberty to nominate a qualified person to fill up the vacancy. Every such nomination shall be in the prescribed form and shall be made by an elector in writing and shall be seconded in writing by another elector of the same constituency (One Proposer and Secunder shall support only one candidate).

The nomination shall be accompanied by the consent in writing of the nominee agreeing to serve on the University Authority or Body, as the case may be, if elected, and declaring that he is not already a member of the authority or body, or if he is already a member, his term of office as such, would expire before the membership for which he is seeking election takes effect.

The nomination paper shall be forwarded to the Registrar and Returning Officer through Registered post or deposited in the box provided for the purpose in the office of the Registrar and Returning Officer **before 5.00 PM on 12.05.2023.**
