In pursuance of the provision under Section-10- Other Members (i) of KAU Act .1971, (Act No-33 of 1971) as amended vide (Act No-16 of 2001) Sri. M. Rajan was elected as a representative of the Calicut University in the General Council of Kerala Agricultural University. Accordingly, as per the reference cited Ist above a notification was issued filling up the vacancies including the name of Sri.M.Rajan.


Now the Registrar University of Calicut vide Letter cited second above has informed the term of the senate member Adv. M .Rajan, Advocate & Notary, Silk Street, Kozhikode-673 001 is over since the tenure of the elected Senate of that University expired on **29.09.2017**.

Section 11(2) of KAU Act (Act 33 of 1971) stipulate that “Every Member of General Council other than the Ex-officio member shall , subject to the provisions of this Act and the Statutes, held office until the next reconstitution of the General Council; provided that no member nominated or elected in his capacity as a member of a particular body or as the holder of a particular office shall hold office for a longer period than three months after he has ceased to be such member or holder of such office, unless in the meanwhile he again becomes a member of that body or holder of that office”.

The tenure of Sri.M.Rajan in the General Council of the Kerala Agricultural University is deemed to have expired on **28.12.2017** by the above clause.

Therefore as per the provision under Section 11(2) of KAU Act.1971 it is hereby notified that Sri.M.Rajan is ceased to be a member in the XVII<sup>th</sup> General Council of the Kerala Agricultural University accordingly.
