Sealed quotations are invited for undertaking the **plumbing and electrification work in pseudomonas production unit**. Details of work are specified below.

1	Supplying and fixing of switch boards, Open DB box, 16A sockets, 6mm, 2.5mm 3 run cables, 6MD plates, ELCB, Isolator, MCB, wall fans, tube lights, holders etc. Including fittings of 20mm pvc pipe, bend, flex cables, 20 mm clamp with cycle screws all cost of materials and labour charges, etc.	LMPS
2	Supplying and fitting of sink with inlet and outlet of water connections. 4” dia pipe of 5 lengths with all fitting accessories including clamp, steel nails, sink cock, nylon connection, PVC bend, Tee. Elbow, steel grip etc all cost of materials and labour charges, etc.	LMPS

The rates quoted should be for completion of work mentioned in the schedule. The necessary superscription, due date for the receipt of quotations, the date up to which the rates will have to remain firm for acceptance and the name and address of officer to whom the quotation is to be sent are noted above. Any quotation received after the time fixed on the due date is liable to be rejected. The maximum period required for completion of work should also be mentioned. Quotations not stipulating period of firmness and with price variation clause and/or ‘subject to prior sale’ condition are liable to be rejected.

The acceptance of the quotations will be subject to the following conditions:

1. No representation for enhancement of price once accepted will be considered during the currency of the contract.
2. Any attempt on the part of quotationers or their agents to influence the Officers concerned in their favour by personal canvassing will disqualify the quotationers.

3. If any license or permit is required, quotationers must specify in their quotation and also state the authority to whom application is to be made.
4.
 - a) In cases where a successful quotation, after having made partial supplies fails to fulfill he contracts in full, all or any of the materials not supplied may, at the discretion of the Purchasing Officer be purchased by means of another quotation or by negotiation or from the next higher tenderer who had offered to supply already and the loss, if any, caused to the University shall thereby together with such sums as may be fixed by the University towards damages be recovered from the defaulting quotationer.
 - b) Even in cases where no alternate purchases are arranged for the materials not supplied, the proportionate portion of the security deposit based on the cost of the materials not supplied at the rate shown in the tender of the defaulter shall be forfeited and balance alone shall be refunded.
 - c) Any sum of money due and payable to the contractor (including Security Deposit returnable to him) under this contract may be appropriated by the Purchasing Officer or any other person authorized by University and set-off against any claim of the Purchasing Officer or University for the payment of a sum of money arising out of or under any other contract made by the contractor with the Purchasing Officer or any other person authorized by University.
5. The prices quoted should be inclusive of all taxes, duties, cesses, etc., which are or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery during the course of execution of the contract.
6. Any sum of money due and payable to the successful quotationers or contractor from University shall be adjusted against any sum of money due to University from him under any other contracts.
7. Special conditions, if any, printed on the quotation sheets of the quotationers or attached with the quotation will not be applicable to the contract unless they are expressly accepted in writing by the purchaser.
8. Withdrawal from the quotation after it is accepted or failure to supply/complete within a specified time or according to specifications will entail cancellation of the order and purchases being made at the offerers expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the University reserves also the right to remove the defaulter's name from the list of University suppliers permanently or for a specified number of years.

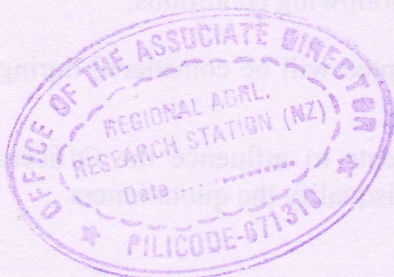
