Sealed competitive tenders are invited for construction of poly house at RARS Pilicode .

**Specification**

Area: 30 m x 10 m, 4 m height

Works involved:

1. Land levelling and excavation work for structure.
2. Truss work of poly house and door structure using G.I. pipe
  - 65 mm, 16 gauge dia or nearest size GI Pipe for Pillar posts,
  - 35 mm , 16 gauge dia or nearest size GI Pipe for Truss, Truss Purlin, Truss Bottom Centre Support Purlin, Side Beams, Single door with latches & hinges etc for the poly house
  - 25 mm (1") dia or nearest size GI Pipe for Truss Support Centre lines, Truss Support Slant lines for the Poly house
3. Fixing and covering the structure with 200 micron U.V. protected clear sheet for roofing the Polyhouse.
4. Powder coated Aluminium Spring for fixing the UV sheets, complete for the Polyhouse
5. Poles/ pillars should be concreted and fixed well.
6. The poly house should be naturally ventilated.



7. Door should be included of size 2m x 1m using same material.

**1. Tender form**

2. **Earnest Money Deposit:** An EMD of **Rs.2,980/-- (Rupees Two Thousand Nine Hundred and Eighty Only)** should be remitted by separate DD drawn in favour of Associate Director, Regional Agricultural Research Station. Pilicode Pin-671310.

**Agreement:-**

- 1 The tender should be accompanied by an Agreement in Kerala stamp paper worth **Rs.200/-(Rupees Two hundred only)** in the format that can be downloaded from the website [www.kau.edu/tenders](http://www.kau.edu/tenders) OR [rarspil.kau.in/tenders](http://rarspil.kau.in/tenders).
- 2 The sealed cover containing the tender documents should be super scribed as **“Tender for construction of Polyhouse”** .The cover should contain the DDs for tender cost, GST, EMD and the Agreement as mentioned above.
- 3 The successful tenders should execute an agreement in Kerala Stamp paper worth **Rs.200/-(Rupees Two hundred only)** and furnish a security deposit of 5% of cost of the rate quoted in the form of term deposit/bank guarantee/demand draft drawn in favour of Associate Director, Regional Agricultural Research Station, Pilicode, Pin 671310, Kasargod District payable at the State Bank of India, Kayyur (Branch code SBTR000573), when directed from this office.
- 4 The rate, tax and other charges if any should be separately stated.
- 5 The Associate Director has the right to accept or reject any or all of the offers without assigning any reason.
- 6 The successful tenderer shall initiate the work/supply the item within one week of award and should finish the supply within one month.
- 7 If any hartal/strike/any unexpected holiday occurs on the date of opening of tender, the tender will be opened at the same time on the next working day.
- 8 All the rules and regulation applicable to government tender will be applicable to this tender also.
