**Cage Wheel ( 1 set) - Specifications:**

1. a) Side ring with 50 x50x 6 mm thickness MS angle  
b) side ring outer diameter 44.5 inch
2. a) Centre ring thickness 50 x 12 mm MS flat  
b) Centre ring outer diameter 52 inch
3. Disc 50 x 12 mm thickness MS flat with 8 holes
4. 50 x 50 x 6 mm thickness MS angle for blade
5. Cross or support thickness 32 x 10 mm MS flat
6. Wheel size width 35 inch
