2. **Earnest Money Deposit:** An EMD of Rs.20,000/- (Rupees Twenty thousand only) should be remitted by separate DD drawn in favour of Associate Director, Regional Agricultural Research Station. Pilicode Pin-671310.
3. The tender should be accompanied by an Agreement in Kerala stamp paper worth Rs.200/- (Rupees Two hundred only) in the format that can be downloaded from the website www.kau.edu/tenders OR rarspil.kau.in/tenders
4. The sealed cover containing the tender documents should be super scribed as "Tender for supply of Combined harvester at RARS Pilicode". **The cover should contain the DDs for tender cost, GST, EMD and the Agreement as mentioned above**
5. 
