- Tender should be submitted in the prescribed forms which can be downloaded from the website www.kau.edu/tenders. The cost of the tender forms will not be refunded under any circumstances.
- 2. The sealed cover containing the tender should be super scribed "Refilling of gas cylinders" in the Department of Soil Science & Agricultural Chemistry (along with the notification number) and addressed to the Dean, College of Agriculture, Padannakkad.
- 3. Each tender should be accompanied by Tender fee, Earnest Money Deposit (EMD) and GST paid by way of three separate crossed Demand Drafts drawn in favour of Dean, College of Agriculture, Padannakkad payable at Nileshwar. Late and incomplete tenders and tenders without EMD, tender fee and agreement will not be accepted.
- 4. All the MSMEs with Udyog Aadhar registration or any other body specified by the Ministry of Micro, Small and Medium Enterprises working within the State of Kerala will be exempted from payment of Tender Fee and Earnest Money Deposit. Such firms should furnish a copy of the existing valid certificate received from the authorized Ministry /Agency at the time of submission of tender.
- 5. The tender should be accompanied by an agreement in Kerala Stamp Paper worth Rs. 200/- (Rupees Two Hundred only). Format can be downloaded from the above website.
- 6. The successful tenderer should execute an agreement in Kerala Stamp Paper worth Rs. 200/- (Rupees Two Hundred only) and should furnish a security deposit of 5% of the total cost of the items quoted in the form of Cash / Bank Guarantee of any Scheduled Bank in India / Demand Draft drawn in favour of the Dean, College of Agriculture, Padannakkad, payable at Nileshwar when directed from this office. - 7. The cost of the item, tax and other charges should be stated separately.
- 8. The exact specification, details of make, model, name of manufacturer, warranty details etc., of the item must be clearly specified.

- 10. Withdrawal of tenders after its acceptance or failure to supply the item or not according to the specification will entail cancellation of the tender.
- 11. The supply order will be issued on the acceptance of the tender and the invoice should be addressed to the Dean, College of Agriculture, Padannakkad. The payment will be effected only after satisfactory supply of the item.
- 12. The successful tenderer should supply the item to College of Agriculture,

Padannakkad within one week from the date of the receipt of the supply order.

- 13. The Dean, College of Agriculture, Padannakkad has the right to accept or reject any or all of the offers without assigning any reason.
