Sealed competitive quotations are invited for the supply of Manure Sieving Machine specified below. The rates quoted should be for delivery of the articles at the place mentioned below. Any quotation received after the time fixed on the due date is liable to be rejected. The maximum period required for delivery of the articles should also be mentioned. Quotations not stipulating period of firmness and with price variation clause and/or 'subject to prior sale' condition are liable to be rejected.

Manure Sieving Machine	1 No.	 Cylindrical Type. Electrically and manually operated. Sieve size-120 cm length,60 cm diameter, mesh size 5 with 20 gauge wire. Top loading tray with stand. Side covered with CR sheet. Motor-1 HP single phase,900 RPM. Warranty –Minimum 1 year.

The acceptance of the quotations will be subject to the following conditions:-

- 1. Acceptance of the quotation constitutes a concluded contract. Nevertheless, a successful quotationer must within a fortnight/a month after the acceptance of his quotation execute an agreement on Kerala Stamp Paper for Rs.200/- at his own cost for the satisfactory fulfillment of the contract, if so required.
- 2. The items should be delivered at this station, ie, Rice Research Station, Moncompu(Kerala Agricultural University)Thekkekara P.O, Alappuzha-688503, Kerala upon the issuance of supply order. The item supplied will be returned if they do not meet the stipulated specifications and quality.
- 3. Withdrawal from the quotation after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order and purchase being made at the offerer's expenses from, elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the University reserves the right to remove the defaulter's name from the list of University suppliers permanently or for a specified number of years
- 4. No representation for enhancement of price once accepted will be considered during the currency of the contract.

5. If any licence or permit is required quotationers must specify in their quotation and also state the authority to whom application is to be made.

6. The prices quoted should be inclusive of GST, other charges etc. which are or may become or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery during the course of execution of the contract.

7. The cost of the item, tax and other charges should be separately stated.

8. The exact specifications, details of make, model, name of manufacturer, warranty details, cost of 2 years of extra warranty etc. of the items must be clearly specified. Copies of detailed technical literature and illustrated brochures of the units quoted are to be included along with the offer. Details of maintenance service contract offered after expiry of normal warranty, spare-parts availability and after-sale-service facilities available should be indicated. Offers without these are liable to be rejected.

9. The decision of the undersigned in finalizing the tenders will be final and binding.

10. If any Bandh/Harthal/Strike/any unexpected holidays occurs on the date of opening of quotation, the quotation will be opened at the same time on the next working day.
