Terms and conditions:

- 1. The Tenders superscribed "Microsoft 365 Campus Agreement" should be addressed to the Director of Information Systems, Academic Block 1, College of Agriculture, Vellanikkara. The last date for the receipt of filled in Tenders is 3.00 pm on 20 December 2025 and the same will be opened at 11.00 AM on 22 December 2025 in the presence of tenderers or their authorized representatives who may be present at that time. The cost of tenders has to be remitted in the by means of DD or cheque drawn in the name of Comptroller Kerala Agricultural University
- Tender should be submitted in the prescribed form which can be downloaded from the
 website www.kau.in/tenders. The cost of the tender forms will not be refunded under any
 circumstances.
- 3. Each tender should be accompanied by an Earnest Money Deposit of 1% of the total quoted amount in the form of demand draft drawn in favour of Director of Information Systems, Kerala Agricultural University payable at SBI, Vellanikkara branch. Full details regarding DD of EMD/Tender Fee should be mentioned in the tender document. The tender should be accompanied by an agreement in Kerala Stamp Paper worth Rs. 200/- (Rupees Two Hundred only) and format can be downloaded from the above website. Withdrawal of tenders after its acceptance or failure to supply the items or supplies not in accordance with the specification will entail cancellation of the tender. The successful tenderer should supply the item to Directorate of Information Systems, Vellanikkara within ten days from the date of the receipt of supply order. The Director of Information Systems reserves the right to remove the defaulted name from the list of suppliers permanently or for a specific period.

- 4. Copies of Registration certificate, GST Registration are also enclosed along with tender documents
- 5. The successful tenderer should execute an agreement in Kerala Stamp Paper worth Rs.200/(Rupees Two Hundred only) and furnish a security deposit of 5% of the cost of the entire
 quantity of items quoted in the form of term deposit/ bank guarantee/ demand draft drawn
 in favour of Director of Information Systems, Vellanikkara. The format for the agreement
 can be downloaded from the KAU website.
- 6. The cost of the items should be quoted inclusive of all taxes and installation, transportation, loading and unloading and other applicable charges.
- 7. The rate shall be valid for a period of one year from the date of acceptance of tender.
- 8. The Director of Information Systems, KAU reserves the right to accept or reject any or all of the offers without assigning any reason.
