If any Harthal/strike/any unexpected holiday occurs on the date of opening of quotation, the quotation will be opened on the next working day.
4. The rate quoted should be inclusive of all taxes and transportation charges.
5. The exact specification, details of make, model, name of the manufacturer etc of the item must be clearly specified in the technical literature and brochures of the item have also to be furnished along with the quotation.
6. The warranty/ service details should be clearly specified in quotation. Minimum of one year warranty is required as per rules.
7. The lowest rate offered as per the specifications will be accepted if reasonable.
8. The item should be supplied within 07 days on receipt of supply order issued from this office.
