Late Quotations will be rejected. The quotation will be opened on 12/08/2024at 3.30 PM. The envelope should be superscribed as "Quotation for supply of Field Boards and Field Labels".
- 2. The EMD is 2.5% of quoted amount. The EMD of all bidders except those in whose favour the quotation is confirmed will be returned soon after the quotation process is over. The EMD of those in whose favour the quotation is confirmed, will be converted as Security Deposit and released after the quotation period on recommendation of the concerned officer.
- 3. If the lowest rate offered is found reasonable in comparison with the local market rate, the quotation will be confirmed for that rate provided all conditions are met.

- The successful quotationer will remit 5% of quoted amount as security deposit and execute an agreement in Kerala Stamp Paper worth Rs. 200/-.
