#### ORDER

As per the paper read above, the Programme Co-ordinator, KVK Wayanad has informed that they have collected around 50 tons of cow dung from Pookode Veterinary University for nursery use and her ce a storage facility is essential for keeping it safely.

Accordingly, the Programme Co-ordinator, KVK Wayanad has requested permission for constructing a low cost rain shelter for storage of cow dung, utilizing their Revolving Fund. Also they have forwarded an approximate estimate costing Rs. 1,00,000/- (Rs. One Lakh only) for constructing the proposed shelter.

Under the circumstances, following orders are issued:

- Sanction is hereby accorded to the Programme Co-ordinator, KVK Wayanad for constructing a rain shelter for storage of cow dung in the nursery unit at KVK Wayanad utilizing the Revolving Fund at a cost not exceeding Rs. 100,000/-.
- 2. The Programme Co-ordinator, KVK Wayanad shall strictly comply with the rules and regulations and will submit a detailed report and relevant certificates after completion of the work.
