For oligonucleotides primer synthesis rate per base pair should be quoted. The item should be supplied within two weeks from the date of supply order. Further details can be had from office during working hours.

Quotations for bulk purchase of Agar, Dextrose, D-Mannitol, Carboxy Methyl Cellulose (CMC), Di-Potassium Hydrogen Phosphate, Glycerol, Magnesium Sulphate, Ms supplement, Peptone, Surgical blades, Filter papers (white circle) and cotton (Absorbant & Non Absorbant) are also invited.

The last date of receipt of the rate contracts is at 2.30 PM on 29.08.2024 and will be opened at 3.00 PM on the same day in the presence of quotationers or their representatives whoever may be present.

Conditions :-

1. Include manufacturers authorization form in the Rate Contracts/ Quotation.
2. Item should be delivered free of cost at the site.
3. **Price:** As quoted in the Rate Contracts/ Quotation the Price List for the financial year 2024-25, the prices are inclusive of packing and forwarding charges and C&F on destination basis.
4. **Price Variation:** No revision in rates on higher side will be accepted. If at any time during the said period, the contractor reduces the sale price of the articles covered under the contract to any other Department/ persons, the benefit of such reduction will be immediately extended to this Rate Contracts/ Quotation also.
5. **Taxes:** As per the Government rules.

6. **Period of Contracts/Quotation** : Generally the contract shall remain in force upto 31.03.2025.
7. **Extention of Rate Contract/Quotation** : The firms can extend the Rate Contract/ Quotation for a total period of one year from today at the prevailing prices and terms and conditions of Rate Contracts/ Quotation, if agreeable.
8. **Quantity of items purchased** : The contractor has to supply all the items in accordance with the supply orders received.
9. **Quality of items supplied** : The items supplied should be of good quality and must comply with the specifications given in the Rate contract price lists. Free replacement should be made immediately with regard to quality or discrepancy found, if any .In the case of lab chemicals, consumables,etc..the expiry date must be legibly recorded on the bottles or on its wrappers.
10. **Cancellation Rate Contracts/Quotation**: The Professor and Head reserves the right to cancel the rate contract without any notice if the supply of items are found not satisfactorily.
