TERMS AND CONDITIONS:

The cost of tender form is Rs 0.20% of the cost of tender (rounded to nearest 100/-, minimum Rs. 400/- and a maximum of Rs.1500 + 18% GST separately). A DD for the amount drawn in favour of The Professor and Head, ARS Anakkayam, payable at SBI Manjeri Town branch should be enclosed along with the tender submitted.
2. Earnest Money Deposit (EMD) @ 1 % of the cost of items subject to minimum of Rs. 1500/- offered may be remitted by a separate DD drawn as detailed above. Firms which are exempted from payment of EMD should furnish copy of current valid certificate.
3. Agreement on Kerala Stamp paper for Rs. 200.00. Form of agreement can be downloaded from the website <http://www.kau.in/tenders> under the Related Documents section.

4. The tender should be in the sealed cover and to reach the undersigned on or before **01.12.2025** at **2.00 pm**. Tenders received late or incomplete in any respect will be summarily rejected without notice and the decision of the undersigned on such matters will be final.
5. The tenders will be opened at 2.30 pm on the same day in the presence of those who are present at that time. The lowest rate will be accepted if reasonable.
6. Successful tenderers will have to execute an agreement and remit security deposit @ 5% of the value of the articles ordered, less the amount of EMD, drawn as DD or fixed deposit receipt.
7. The sealed cover containing the tender documents should be superscribed "Tender for supply of chemicals for the production of KAU Multimix Sampoorana" (along with the notification number) and sent to The Professor and Head, ARS Anakkayam, Malappuram District - PIN 676509
8. Supply should be in 2-3 batches as and when required. The party have to supply all the 8 items at a time, irrespective of the quantity. Supply some items immediately and others at a later period are not acceptable. The supply has to be made in a period of one week from date of placement of order
9. The lowest tender will be identified based on the lowest cumulative total of all the items taken together for the above said quantity.
10. The rate quoted should be inclusive of all taxes including GST, transportation charge & other charges if any and also connected expenses if any. The cost of item, tax and other charges should be stated separately.
11. The rate will be valid for the financial year 2025-2026. The payment will be through invoice/credit bill system and by cheque only.
12. The decision of the Professor & Head, ARS Anakkayam will be final and abiding.
13. The undersigned reserves the authority to accept or reject any or all the tenders without assigning any reason.
