In case the tenderer is quoting for any one item or a combination of two items, the superscription should clearly indicate the specific item(s) quoted and should be addressed to **The Assistant Comptroller, Internal Audit Circle (NR), Kerala Agricultural University, Sujatha Building, Vellimadukunnu, Kozhikode - 673012.**
2. The item should be delivered and installed at the site and the rate quoted for the item should be inclusive of installation charges, taxes, delivery charges and other charges, if any, and should be valid for one-year w.e.f. the date of issue of supply order.
3. The period of warranty for the items should be stated separately.
4. The Tender form shall be downloaded from the link, www.kau.in/tenders. The same should be submitted duly signed along with other documents.
5. The cost of the tender form, GST and EMD will be accepted by way of separate Demand Drafts drawn in favour of the **Assistant Comptroller, Internal Audit Circle(NR), Vellimadukunnu** payable at State Bank of India, Eranielipalam, Kozhikode.
6. The tender should be accompanied by an Agreement in Kerala Stamp Paper worth **Rs.200/-** and the format of the Agreement (Format of agreement to be submitted along with the tender) can be downloaded from the link, www.kau.in/tenders.
7. Late and incomplete tenders and tenders without EMD, Cost of Tender, GST and Agreement will not be accepted. Firms who are exempted from the payment of EMD should furnish a copy of the currently valid certificates from Store Purchase Department, Govt. of Kerala.
8. Tenders will be opened in the presence of the tenderers who may be present at that time.
9. If the date of opening the tender happens to be a holiday due to unexpected circumstances like bandh, hartal etc., quotations will be opened on the next working day at the same place and time.
10. The successful tenderer should execute an agreement in Kerala stamp paper worth **Rs.200/-** and furnish a **Security Deposit of 5%** of the cost of items quoted in the

form of Term Deposit /Bank Guarantee/Demand Draft drawn in favour of the **Assistant Comptroller Internal Audit Circle (NR), Vellimadukunnu** payable at the State Bank of India, Eranhipalam when directed from this office. The format (Format of agreement to be submitted at the time of supply of items) of the agreement can be downloaded from the following link www.kau.in/tenders.

11. Withdrawal of tender after its acceptance or failure to supply the items or not according to the specifications will entail cancellation of the tender.
12. The supply order will be placed immediately on the confirmation of the tender and availability of funds.
13. The items should be supplied within 15 days from the date of receipt of supply order and no extension of date is allowed for supply.
14. The invoice should be addressed to **The Assistant Comptroller, Internal Audit Circle(NR), Kerala Agricultural University, Sujatha Building, Vellimadukunnu, Kozhikode - 673012.**
15. Tenders insisting payment in advance either full or part are liable for rejection.
16. Payment as per the invoice will be made only after supply and installation of the item as per specifications and the tenderer is liable to rectify/replace the defective articles immediately on receipt of intimation. TDS on GST @ 2% will be deducted on payment made to the supplier, where the total value of supply under individual contract exceeds Rs. 2.5 lakhs.
17. The Assistant Comptroller, Internal Audit Circle (NR), Vellimadukunnu has the right to accept or reject any or all of the offers without assigning any reason. The decision of the undersigned in finalizing the tenders will be the final and binding.
18. The EMD/Security Deposits furnished will be forfeited in case the contract is not fulfilled as per the terms and conditions mentioned in the tender notice and Agreement.
