- Earnest Money Deposit (EMD) EMD @ 1% of the cost of equipment offered may be remitted by a separate Demand Draft drawn as detailed above.

- 5. The offer for the item should indicate separately the basic unit, accessories and optional and its cost. Taxes, customs and excise duty, packing, forwarding, insurance and any other cost for its installation, if any should also be included.
- 6. The sealed cover containing the tender documents should be super scribed "Tender for supply of VCO PROCESSING COOKER (LPG) -Tank capacity 60 Ltrs" and sent to Programme coordinator, Krishi Vigyan Kendra, Ambalavayal, 673593, Wayanad, Kerala.
- 7. Tenders received late or incomplete in any respect will be summarily rejected without notice and the decision of the undersigned on such matters will be final.
