Construction of a naturally ventilated Poly house (Structure)	Size – 15 length, 7 m width Shape – Gable or Tropical Center height – 7 m Gutter height – 4 m from floor area Foundation pipes - 65mm OD & 2 mm thickness (Concreting and fixing of pillars are required) Columns – 76 mm OD & 2 mm thickness Trusses - 60 mm OD & 2mm thickness Top arches of the truss - 42mm OD & 2mm thickness Purlin - 42mm OD & 2mm thickness Purlin member & others – 33 mm OD & 2mm thickness Stay for the structure – Minimum two stay support on every 4 corners with 48 mm OD pipe Gutter material – 1 mm thick GI sheet with 500 mm perimeter Entrance room & Door - Entrance room size 2m x 2.5 m x 3 m (L x W x H) Double door – Size - 2.5 m height & 2 m width Misting - Mist system with anti-leak mechanism and a filter. Others - Necessary clamps, nuts, bolts, self-drilling screws and washers etc. of SS 202 grade.

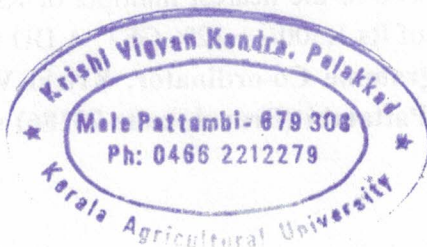
1. The tender should be submitted in the prescribed form which can be downloaded from the website: www.kau.in/tenders.
2. **The cost of tender form is 0.2% of PAC rounded to the nearest multiple of Rs.100/-** subject to a minimum of Rs.400/- and maximum of Rs.1,500/- + 12% GST. A DD for the amount should be drawn in favour of the **Programme Co-ordinator, Krishi Vigyan Kendra Palakkad, Pattambi, payable at SBI Pattambi (Branch code-70186)** should be enclosed along with the tender submitted.

3. **EMD @ 1%** of the amount quoted should be remitted by separate DD drawn in favour of the **Programme Co-ordinator, Krishi Vigyan Kendra Palakkad, Pattambi, payable at SBI Pattambi (Branch code-70186)**.
4. The tender should be accompanied with a duly signed agreement in Kerala stamp paper worth Rs.200/- (Rupees Two Hundred only) in the format that can be downloaded from the website: www.kau.in/tenders.
5. The sealed cover containing duly filled and signed tender documents should be superscribed "**Tender for the Construction of a naturally ventilated poly house**" and addressed to the **Programme Co-ordinator, Krishi Vigyan Kendra Palakkad, Melepattambi, PIN-679306**. The cover should also contain separate DDs towards the Tender cost (including GST) and EMD, and Agreement as mentioned above.
6. The successful bidder should execute an agreement in Kerala stamp paper worth Rs.200/- (Rupees Two Hundred only) and furnish a **security deposit @ 5%** of the amount quoted in the form of Term Deposit/Bank Guarantee/Demand Draft drawn in favour of the **Programme Co-ordinator, Krishi Vigyan Kendra Palakkad, Pattambi, payable at SBI Pattambi (Branch code-70186)**
7. The rate quoted, tax and other charges if any should be separately stated.
8. The Programme co-ordinator has the right to accept or reject any or all the tenders without assigning any reason. The decision of the undersigned in finalizing the tenders shall be final and binding.
9. If any hartal/strike/any unexpected holiday occurs on the date of opening of tender, the tender will be opened at the same time on the next working day.
10. The successful bidder should execute the work within 30 days from the date receipt of work order.
11. Any failure on the part of the supplier in the fulfillment of contractual obligations will result in the forfeiture of EMD/Security Deposit.
12. All the rules and regulations applicable to Government tender will be applicable to this tender also.

Special Conditions:

- Tender insisting payment in advance either full or part for supply and execution of work of the work are liable for rejection.
- Payment will be made after satisfactory installation of the poly house.
