A DD for the amount should be drawn in favour of the Programme Co-ordinator, Krishi Vigyan Kendra Palakkad, Pattambi, payable at SBI Pattambi (Branch code-70186) should be enclosed along with the tender submitted.
3. EMD @ 1% of the amount quoted should be remitted by separate DD drawn in favour of the Programme Co-ordinator, Krishi Vigyan Kendra Palakkad, Pattambi, payable at SBI

- Pattambi (Branch code-70186). Firms who are exempted from EMD should furnish valid copy of certificate from the Store Purchase Department, Government of Kerala.
4. The tender should be accompanied with a duly signed agreement in Kerala stamp paper worth Rs.200/- (Rupees Two Hundred only) in the format that can be downloaded from the website: www.kau.in/tenders.
 5. The sealed cover containing duly filled and signed tender documents should be superscribed "**Tender for the supply and installation of Electric Fruit Pulp Concentrator/Electric Roaster**" and addressed to the Programme Co-ordinator, Krishi Vigyan Kendra Palakkad, Melepattambi, PIN-679306. The cover should also contain separate DDs towards the Tender cost (including GST) and EMD, and Agreement as mentioned above.
 6. The sealed cover should be accompanied by
 - a. Tender form

 - c. Earnest Money Deposit (EMD) by way of DD
 - d. Preliminary agreement in Kerala stamp paper worth Rs.200/-
 - e. Equipment technical specification/brochure
 - f. Service support details.
 - g. Authorization certificate if the bidder is a dealer.
 - h. Purchase order/performance certificate of the quoted model of equipment from Universities/Government institutes/PSUs etc.
 7. The successful bidder should execute an agreement in Kerala stamp paper worth Rs.200/- (Rupees Two Hundred only) and furnish a security deposit @ 5% of the amount quoted in the form of Term Deposit/Bank Guarantee/Demand Draft drawn in favour of the Programme Co-ordinator, Krishi Vigyan Kendra Palakkad, Pattambi, payable at SBI Pattambi (Branch code-70186)
 8. The rate quoted, tax and other charges if any should be separately stated.
 9. The Programme co-ordinator has the right to accept or reject any or all the tenders without assigning any reason. The decision of the undersigned in finalizing the tenders shall be final and binding.
 10. If any hartal/strike/any unexpected holiday occurs on the date of opening of tender, the tender will be opened at the same time on the next working day.
 11. The successful bidder should execute the order within 7 days from the date receipt of supply order.
 12. Any failure on the part of the supplier in the fulfillment of contractual obligations will result in the forfeiture of EMD/Security Deposit.
 13. All the rules and regulations applicable to Government tender will be applicable to this tender also.


Special Conditions:
