The sealed cover containing the tender should be superscribed “**Tender for supply and installation of Electric Fruit pulp concentrator/ Electric roaster at Fruits Crops Research Station, Vellanikkara**” addressed to the Professor and Head, Fruits Crops Research Station, Vellanikkara, Thrissur - 680656.
2. The sealed cover should be accompanied by
  - a. Equipment technical specifications/brochure
  - b. Service support details
  - c. Users list of the equipment
  - d. Feedback certificate from other institutions if any
  - e. Authorization certificate if the bidder is a dealer
  - f. Undertaking to the effect that the bidder is not debarred / blacklisted or banned from any University / Government Institute / PSU.
  - g. Purchase Order and performance certificate of the quoted model of Equipment from three reputed customers, preferably University/ Government Institute / PSU, if any.
  - h. Preliminary agreement in Kerala Stamp paper worth Rs. 200/- (Rupees Two hundred only)
  - i. Tender form
  - j. Tender fee + GST by way of crossed Demand Draft
  - k. Earnest Money Deposit (EMD) by way of crossed Demand Draft

4. Demand draft for tender fee and EMD should be submitted separately. The Demand Drafts should be drawn in favour of the Professor and Head, Fruits Crops Research Station, Vellanikkara payable at SBI, Vellanikkara, Thrissur.
5. Late and incomplete tenders and tenders without EMD, tender fee and agreement will not be accepted. Firms which are exempted from payment of EMD should furnish copy of relevant valid certificate. The cost of tender forms paid will not be refunded under any circumstances.
6. The successful tenderer should execute an agreement in Kerala Stamp paper worth Rs. 200/- (Rupees Two hundred only) and should furnish a security deposit of 5% of the cost of the items quoted in the form of demand draft/ bank guarantee/ term deposit in favour of The Professor and Head, Fruits Crops Research Station, Vellanikkara, Thrissur- 680656 at SBI, Vellanikkara, Thrissur when directed from this office. The format of the agreement can be downloaded from the above website.
7. The cost of the item quoted should be inclusive of all taxes and loading and unloading charges, transportation cost etc. Tax and other charges should be stated separately.

- The exact specification, details of make, model, name of manufacturer, warranty details (**minimum warranty period: 1 year**), Annual Maintenance Contract conditions if any, etc., of the item must be clearly specified. Rate for Annual Maintenance Contract should be specified separately.
9. If any Bandh/Strike/ any unexpected holidays occur on the date of opening of tender, the tender will be opened at the same time on the next working day. The decision of the undersigned in accepting the tenders shall be final and binding.
  10. The supply order will be issued on the acceptance of the tender and the invoice should be addressed to The Professor and Head, Fruits Crops Research Station, Vellanikkara , Thrissur-680656. The payment will be effected only after satisfactory supply and installation of the item.
  11. The successful tenderer should supply the item to Fruits Crops Research Station, Vellanikkara, Thrissur- 680656 within 3 weeks from the date of the receipt of the supply order.
  12. The Professor and Head, Fruits Crops Research Station, Vellanikkara has the right to accept or reject any or all of the offers without assigning any reason.
  13. All the rules and regulations applicable to the Government tenders as per store purchase manual of Government of Kerala will be applicable to this tender also.
  14. Withdrawal from the tender after having accepted or failure to supply within specified time or according to specifications will entail cancellation of the order and attract legal procedures as per agreement.
